## **Personal Data Processing Policy**

The company "IsZEB", based in Thessaloniki, 6th km Charilaou - Thermis, 57 001, (hereinafter "Data Controller" or "Company") hereby informs you that it collects, processes and stores, in electronic and/or physical form, personal data included in the form "New Member Application", i.e. personal information of representative of the applicant legal entity (name, position/affiliation, e-mail, and telephone number), as well as personal details of the self-employed/sole proprietorship applicant (name, VAT number, social security number, address, e-mail, and telephone number), complying with the provisions of the applicable personal data protection legislation, including Regulation (EU) 2016/679 of the European Parliament and of the Council (hereinafter "General Data Protection Regulation" or "GDPR") and Law 4624/2019 as applicable.

The company collects the above personal data from you, exclusively for the purpose of ensuring its proper operation, for the performance of the contract (cooperation agreement) between us, and for your security. The processing of these personal data is necessary for the performance of the contract between us or in order to take steps prior to entering into the contract (Article 6 par. 1 (b) GDPR).

The above personal data will not be transferred to any third party, unless this is required for the fulfillment of the company's legal obligations or is necessary for the fulfillment of the above data processing purposes, in compliance with the applicable legal framework. Authorized members of the company and/or its authorized external partners (e.g. external accountant, etc.) may have access to the above personal data and will process it only for the fulfillment of the above data processing purposes. Also, your personal information may be disclosed to official government and supervising bodies, public authorities, organizations, and courts. The company does not transfer the aforementioned personal data outside the EU/EEA.

The company will retain these personal data only for the reasonable period of time required by the nature of the processing and only for as long as it is required to achieve the above purposes of processing unless a longer retention period is required by law or for the establishment, exercise or defense of legal claims. After the end of the above period of time, the data will be totally deleted/destroyed.

The personal data are strictly confidential and are processed only for the fulfillment of the above purposes. The company implements appropriate technical and organizational measures to ensure an appropriate level of protection against the risks arising from processing, such as accidental or unlawful destruction, loss, alteration, unauthorised disclosure, or access.

Without prejudice to the limitations set out to data protection legislation, you have the following rights:

- Right to access: You have the right to request access to your personal data and you can be informed if we process your personal data, about the purpose and way of their processing, their security, as well as about your rights. You can also request a free-of-charge copy of your personal data undergoing processing.

- Right to rectification: If you believe that your personal data is inaccurate or needs an update, you have the right to request the rectification of the inaccurate information and the completion of the incomplete data.

- Right to restriction of processing: If you consider that your data is inaccurate, or that the processing is unlawful, or that we no longer need your data, or that you have objections to automated processing, you have the right to request the restriction of the processing.

- Right to object to processing: You have the right to object, on grounds relating to your particular situation, at any time to the processing of your personal data, unless there are compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise, or defense of legal claims.

- Right to erasure (“right to be forgotten”): When you no longer wish the processing and retention of your personal data, you have the right to obtain their erasure, unless the processing is necessary for a specific legal purpose.

In addition, you have the right to lodge a complaint with the Hellenic Data Protection Authority, if you believe that the personal data processing is contrary to the applicable data protection framework.
